You are about to purchase a product that is not simple and may be difficult to understand

What is this product?

Type: An Over the Counter (OTC) contract - Foreign Exchange Instrument **Objective:**

The objective of this product is to manage adverse movements in currency rates that you may experience. Note that it may not provide you with complete protection against such exposures. The product achieves its objectives by Bank of Scotland plc agreeing the terms of an OTC contract with you which may allow for the exchange of one currency for another at a fixed future date (Expiry Date).

Sample Parameters and pre-agreed circumstances and conditions are set out below for the sale of GBP and purchase of EUR:

The product achieves its objectives as follows:

If, during the term of the contract the FX Spot Rate does not trade at or above the CP Advantage Rate (defined above):

- If, at Expiry Date the FX Spot Rate is trading at or below the Protection Rate (defined above) you may exercise your right to exchange the Fixed Currency (defined above) to the Counter Currency (defined above) at the Protection Rate (defined above).
- If, at Expiry Date the FX Spot Rate is trading above the Protection Rate you are not obliged to exchange the Fixed Currency to the Counter Currency. You may transact an amount you choose at the market FX Spot Rate.

If, during the term of the contract the FX Spot Rate <u>does</u> trade at or above the CP Advantage Rate:

- If, at Expiry Date the FX Spot Rate is trading at or below the Protection Rate you may exercise your right to exchange the Fixed Currency to the Counter Currency at the Protection Rate.
- If, at Expiry Date the FX Spot Rate is trading above the Protection Rate and below the Advantage Rate (defined above) you
 are not obliged to exchange the Fixed Currency to the Counter Currency. You may exchange an amount you choose at the
 market FX Spot Rate.
- If, at Expiry Date the FX Spot Rate is trading above the Advantage Rate you are obliged to exchange the Fixed Currency to the Counter Currency at the Advantage Rate.

Intended Retail Investor:

This product is intended for retail investors with a short to medium time horizon who:

- (i) Have sufficient knowledge or experience with complex financial products; and
- (ii) Have exposure to the relevant foreign currency and want a level of protection against adverse movements in foreign currency exchange rates.


Term:

The term of the Cylinder Plus will depend on how long you wish to protect against adverse movements in foreign currency exchange rates and will be agreed before you enter into the product. The product is a bilateral agreement that cannot ordinarily be

terminated unilaterally by either you or Bank of Scotland plc. The product terms provide that if certain events of default or other termination events occur, Bank of Scotland plc or you may terminate the product early. In such an event, the early termination payments described below will apply and the return (if any) you receive on such termination is likely to be different from the scenarios described in this document.

What are the risks and what could I get in return?

Risk Indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level. **Be aware of currency risk. Where you receive payments in a different currency the final return you get depends on the exchange rate between the two currencies. This risk is not reflected in the indicator shown above.** This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed you could incur significant losses.

Performance Scenarios:

This table shows the money you could get back or pay over the next 12 months, under different scenarios, assuming a nominal value of EUR 10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the product. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. This product cannot be easily ended. This means it is difficult to estimate how much you would get if you end before the recommended holding period. You will either be unable to end early or you will have to pay high costs or make a large loss if you do so. The figures shown include all the costs of the product itself. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Average return is calculated as the Cylinder Plus's market value under each scenario divided by the notional amount.

What happens if Bank of Scotland plc is unable to pay out?

You may be exposed to a risk that Bank of Scotland plc might be unable to fulfil its obligations in respect of the Cylinder Plus. The product is not protected by any local investor compensation or guarantee scheme. This means that if Bank of Scotland plc is unable to pay out, you may not receive any amount from Bank of Scotland plc under the product.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs

take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, over the recommended holding period. They include potential early exit penalties. The figures assume a nominal value of EUR 10,000. The figures are estimates and may change in the future.

Costs over time:

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.

How long should I hold it and can I take it out early?

Recommended holding period: This product is designed to be held to the agreed Expiry Date in order to match your investment requirement. It is a product designed to be entered into for its term and cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of Bank of Scotland plc, in which case early termination payments may apply.

Early exit impact: If the product is terminated early, in whole or in part, an Early Termination Payment may become payable by either you or Bank of Scotland plc. The Early Termination Payment is linked to market parameters and could be a substantial loss or gain to you. Settlement on early termination will be specific to your Cylinder Plus and will be influenced by a number of factors which include but are not limited to: whether it is an increasing or decreasing foreign exchange rate environment; the movement of the FX Spot Rate since the transaction Trade Date; the amount affected by the early termination.

The Early Termination Payment is not a penalty charge. The sum represents the economic value of what Bank of Scotland plc would have paid or received if the product continued as agreed. Depending on market conditions at the time of the early termination, the settlement calculated could result in a substantial amount being due from you to Bank of Scotland plc.
